## Section 2 - Hazards Identification

**Emergency Overview:** A colored paste product with a slight odor. **WARNING!** May cause eye, skin, nose, throat and respiratory tract irritation. May cause eye or skin irritation. Harmful if swallowed or absorbed through the skin.

**Effects Of Overexposure - Eye Contact:** Causes eye irritation. Signs and symptoms may include: pain, tears, swelling, redness and blurred vision.

**Effects Of Overexposure - Skin Contact:** Causes Moderate skin irritation. May cause skin irritation. Harmful if absorbed through the skin. Prolonged or repeated skin contact can result in sensitization and dermatitis.

**Effects Of Overexposure - Inhalation:** Vapor harmful. During application and cure, this product releases methanol, which may affect the brain or nervous system causing dizziness, headache or nausea. Vapor harmful. Inhalation of high concentrations may cause headache, nausea, and dizziness. Inhalation may cause irritation to the respiratory tract (nose, mouth, mucous membranes). Inhalation may cause mild irritation to the respiratory tract (nose, mouth, mucous membranes). May cause blurred vision. May cause drowsiness. Overexposure by inhalation may injure the liver.

**Effects Of Overexposure - Ingestion:** Harmful if swallowed. Ingestion may cause gastrointestinal irritation, nausea, vomiting and diarrhea. Ingestion may result in obstruction when material hardens.

**Effects Of Overexposure - Chronic Hazards:** Repeated or prolonged exposure may cause respiratory system damage.

Prolonged and repeated skin contact may cause irritation and possibly dermatitis. Overexposure may cause kidney, cardiovascular, skin and liver damage.

A mixture of diisodecyl phthalate and diisononyl phthalate has been tested in a two-generation toxicity study in laboratory animals. No effects on reproductive parameters were seen. However, a small but statistically significant increase in early offspring mortality was seen at high oral doses. The significance of this to humans is uncertain.

Trimethoxyvinylsilane may cause heart muscle damage, anemia and lung, liver and kidney damage.

## Section 4 - First Aid Measures

**First Aid - Eye Contact:** In case of contact, immediately flush eyes with large quantities of water for at least 15 minutes until irritation subsides. Get medical attention immediately.
