SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Organic #2. Store with alcohols, glycols, amines and amides. Keep container tightly sealed. Store in a cool, dry place.

SECTION 8 — EXPOSURE CONTROLS, PERSONAL PROTECTION

Avoid contact with eyes. Wash hands thoroughly after handling.

White powder. Odorless.
