SECTION 2 — HAZARDS IDENTIFICATION

Flinn Suggested Chemical Storage Pattern: Organic #9. Store with dyes, indicators, and stains. Light sensitive. Turns yellow on exposure to light. Store in a cool, dry place away from light. Keep container tightly closed (P233). Use only in a hood or in a well-ventilated area (P271).
