Section 3 - Hazards Identification

*** Emergency Overview ***: Contents Under Pressure. Harmful if inhaled. May affect the brain or nervous system causing dizziness, headache or nausea. Harmful if swallowed. Extremely flammable liquid and vapor. Vapors may cause flash fire or explosion.

Effects Of Overexposure - Eye Contact: Causes eye irritation.

Effects Of Overexposure - Skin Contact: Prolonged or repeated contact may cause skin irritation. Substance may cause slight skin irritation.

Risk of overexposure depends on duration and level of exposure to dust from repeated sanding of surfaces or spray mist and the actual concentration of Titanium Dioxide in the formula.

Reports have associated repeated and prolonged occupational overexposure to solvents with permanent brain and nervous system damage.
